This contract is written for the protection of both the Purchaser and the Seller, & when signed becomes binding and legal.

Sound health and temperament of said cat/kitten is guaranteed upon arrival. Health records and a care sheet are provided at time of sale. Also included is a four generation pedigree. This kitten sold as:

All pet kittens must be spayed/neutered before reaching 7 months of age. Seller agrees to furnish registration papers for the cat/kitten upon presentation of a Veterinarian's certificate of sterilization. If buyer breeds said cat without express written permission of the breeder, penalty will result in forfeiture of cat and/or monetary fine of \$2000.00.

Health is guaranteed for a period of 72hrs. from the time the kitten leaves the possession of the seller. It is recommended that you take the cat/kitten to your Veterinarian (at your expense) within this time period for your own satisfaction and protection. If the cat/kitten is found after such examination to have any type of life threatening problem, it may be returned, and the purchase price will be refunded or replacement kitten offered as available. For the protection of the Seller's resident cattery population, a portion of the purchase price will be retained for FeLV and FIV testing. All return shipping related expenses to be the responsibility of the purchaser. Once the cat/kitten leaves the possession of the breeder, said breeder (Abundadots Cattery, Suzanne Merrill) can not be held responsible for any Veterinarian bills or charges incurred on said cat/kitten.

Should the cat/kitten die as a direct result of a congenital defect (unknown at time of sale) within two years of time of sale, said cat/kitten will be replaced **ONLY** if an appropriate necropsy is performed by a licensed Veterinarian and a Vet's certificate is provided showing proof of cause of death. A replacement kitten of comparable quality and value, as available, will be made at the discretion of the Breeder/Seller.
